Trustee Piper moved, seconded by Trustee Sutton to amend the Agenda to insert Section I – Policies & Procedures, Item I-1, 2<sup>nd</sup> Reading of Policy #537.1 – Student Data Privacy and Security Policy to follow Section E. Motion carried 4-0.

E- 1 – DISCUSS/APPROVE DRIVER'S ED CAR LEASE AGREEMENT AND INSTRUCTION (7:04-7:07pm) BOARD ACTION 2015-01-04

Trustee Uhlenkott moved, seconded by Trustee Sutton, to approve the lease agreement with Trustee Piper in the amount of \$1.00 for the use of his automobile for the Driver's Ed Program this spring, to approve payment for the Driver's Ed instructor in the amount of \$25 per hour, and to approve a fee of \$175 to students enrolled in the course. Motion carried 3-0, with Trustee Piper abstaining.

E-2 - DISCUSS/APPROVE ADVERTISING FOR CERTIFIED TEACHING POSITIONS FOR THE 2015-2016 SCHOOL YEAR (7:08-7:10pm) BOARD ACTION 2015-01-05

Trustee Uhlenkott moved, seconded by Trustee Piper to advertise for a secondary math and/or science teaching position and an elementary teaching position. Motion carried 4-0.

Trustee Piper moved, seconded by Trustee Uhlenkott to approve the contract for building erection with Jake Holcomb Construction, LLC, to include the wording in *Section XII. Grounds for Withholding Payment, Item B*, that the Owner will "pay up to ninety-percent (90%) of total contract amount until final inspection when the reason for withholding payment no longer exists." Motion carried 4-0.
